2023 AMERICAN GOLF CENSUS UNLIMITED GOLF SWEEPSTAKES Official Rules

- 1. Eligibility: 2023 American Golf Census Unlimited Golf Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia and legal residents of Canada (except Quebec) who are at least eighteen (18) years old at the time of entry. Sponsor's computer is the official time-keeping device for the Sweepstakes.

How Promotion to Enter: During the Period. visit http://www.americangolfcensus.com and follow the links and instructions to complete and submit the registration form including a valid email address. You automatically will receive one (1) entry into the Entry Period. Each participant may personally enter one (1) time during the Promotion Period.
